## 4.1 GP access and care home Enter and View Visit project paper

Healthwatch Westminster have regular meetings with the Old People's Voice Group to map out the health and care facilities that require focus. We also use information we have received about concerns regarding care homes and GP clinics to help prioritise our visits. Finally, we have quarterly meetings with the CQC team to discuss current inspections and ratings of health care facilities. We have currently made amendments below following up from our current meetings with the CQC team.

As part of our statutory power to conduct Enter and View Visits, Healthwatch Westminster will commence Enter and View to the following three GP and three Care Homes below:

#### **E&V GP practice summary:**

#### <u>Patients experience</u>

The experiences of most patients vary according to their age, gender, ethnicity, digital literacy, language proficiency in English, and mental capacity.

#### <u>Internal appearance</u>

Often times the internal appearance is neat and tidy, with notice board information kept up to date, and available in different fonts. However, there were instances in



which the toilet had a foul smell due to sewage works. Staff names/pictures were visible across all practices. For two practices, the complaint box was prominently displayed, while it was ambiguous for one practice which also functioned as a prescription box and a notice board instructing patients to submit a complaint online. Hand sanitiser stations were present at all clinics; however, Grand Union healthcare only had one station that was only in the waiting area, and not upon entry. A play area was generally available at most practices, which made them generally child-friendly.

## **External appearance**

External appearance often is wheelchair accessible with clear signage, however, disabled parking is often not available. According to the practice manager at Grand Union Healthcare Center, the practice applied many times to the council for assistance but was unsuccessful.

#### **Diversity**

It has been observed that all practices offer information in a variety of languages, however, there was one case in which a gentleman who needed an interpreter was given a sign to hold in the waiting area, which stated "My daughter translates for me", despite the fact that he was not accompanied by his daughter. Many clinics have two monitors that are supposed to display the patient's name, but these monitors are often not working, so patients have to depend on the doctor or receptionist to call their name.

## 4.2 Integrated Care System (ICS) Winter pressure project paper

Healthwatch Westminster, RBKC, and Brent have received funding to conduct a series of visits to local food banks and community kitchens, to have conversations with people accessing the services about the winter healthcare they're entitled to and ways to stay well. This work will be carried out from September 2023 – January 2024, expecting to reach more than 700 people over the course of the project. The information we gather will be shared directly with the ICS to help improve future winter planning.

As part of the funding received, we have recruited a Westminster-based Community Champion to support this work.

#### **Intended outcomes:**

- To raise awareness of the winter healthcare residents are entitled to
- To raise awareness about what ways in which people can stay well
- To understand whether residents are aware of the numbers to call in times of an emergency
- To identify current gaps and ways to improve healthcare provisions, e.g. vaccinations, repeat prescriptions, booking appointments, using NHS 111

#### Summary of concerns received so far:

**Vaccine hesitancy** – Some people raised concerns regarding distrust and side effects about getting vaccinated whilst others did not like the feeling of constantly being injected.



**Information and signposting –** Most people are aware of the services especially the emergency services but have not yet had a reason to use the service. Others had not booked because they were not sure if they were eligible for free vaccinations.

**Concerns regarding quality of service –** some residents were not pleased with their experiences accessing their healthcare services and others felt in some instances healthcare professionals failed to inform them of their repeat prescriptions.

**Representation of information**– some residents wanted the leaflets to be in Arabic considering Arabic is one of the most spoken languages in the community other than English. We have requested this from the ICS, and now received information in a range of translated languages.

## **Next Steps:**

- -Our Community Champion will be attending a series of food aid and homeless shelter accommodations in Westminster to speak to residents and distribute winter healthcare information, supported by volunteers.

## 4.3 Maternity project paper

Healthwatch Westminster, RBKC, and Brent have received funding from Healthwatch England to identify how and why standards of maternal care may vary across London boroughs, and make recommendations to ensure that care is equitable across NWL. In particular, we would like to work with women who don't speak English as a primary language to understand their experiences, and whether they are receiving enough information to understand their care and make appropriate choices.

## **Intended outcomes:**

- To identify the current gaps and ways to improve maternal care, especially within migrant communities.
- To raise awareness of the current gaps in maternal care across North-West London.

## 4.4 Mental health needs of homeless communities' project paper

Healthwatch Westminster are interested in identifying and evaluating the mental health needs of the homeless communities in Westminster, especially experience of or accessing primary mental health care services.

#### Intended outcome:

- Identify and evaluate the gaps in current mental health provisions and the mental health needs of the homeless communities
- Identify the variations in factors such as age, ethnicity, and gender, and how these factors affect ability to access mental health services
- Develop recommendations for improving access to primary mental health care services and increasing community awareness of the importance of mental health support amongst homeless communities.

#### 4.5 Digital inclusion of elderly and diverse populations

Healthwatch Westminster and Healthwatch RBKC are interested in speaking to residents aged 50+ about their experiences using digital platforms in GP and secondary care services within the Bi-Borough. We are particularly interested in hearing from diverse population groups, i.e. migrants/people who do not speak English as a first language.

#### Intended outcome:

- Understand experiences of digital exclusion and healthcare access barriers among people who are elderly and from diverse backgrounds (eg, migrants, non-English speakers, etc.)
- Identify the factors that lead to digital exclusion
- Identify best practices for digital tools and platforms through user-testing focus groups
- Develop recommendations to address digital exclusion among vulnerable residents

## 4.6 Intermediate care/step down project

Healthwatch Westminster and RBKC developed this project in collaboration with the Networked Data Lab at Imperial College Londoon. The project aim is to explore the experiences and perspectives of patients and their carers on intermediate or step-down care services. The project findings will be fed back to service providers across Northwest London.

Intermediate care, also known as step-downs or reablement care, is care that is provided by a team of staff to help patients recover and increase their independence. Most of the time it is provided in the home after a patient is discharged from hospital.

#### Intended outcome:

- Explore patients' and carer's experiences and perspectives of intermediate care services provided in Northwest London
- Contribute lived experiences and qualitative context to the existing quantitative patient and care data collected by NDL
- Identify key barriers and challenges to quality intermediate care provision
- Develop recommendations to improve intermediate care

## 4.7 Update on previous and upcoming projects paper

Alongside our current active projects, there are a number of additional priority areas that are either in the monitoring or planning stages.

#### Healthwatch Westminster Young people's mental health report

Our <u>young people's mental health report</u> was published at the end of November and shared to all Advisory Board members on the 29 November 2023.

We also hosted a co-production event on the 29 November 2023 to share <u>report findings</u> and co-produce next steps with service users and service providers.

We have shared a summary of our findings with our strategic stakeholder network, and presented the findings to the RBKC council Safeguarding Adults Execute Board (SAEB) (2023), and Royals Marsden Teenage and young adult's forum (young cancer patients) (2024).

We are still in the process of recruiting and advertising the young Healthwatch network within our in-person engagement and online engagement.

#### **Healthwatch Westminster Gordon Hospital report**

Our <u>Gordon hospital report</u> was published in October 2023. Since then, we have presented our findings with community organisation that support mental health services for homeless and rough sleepers, Westminster and RBKC council, commissioners, the public, and other relevant stakeholders.

We have also attended CNWL Public Consultation event on the 27 November 2023, Scrutiny committee meetings (providing verbal updates sharing insights from our reports), and the consultation event 31<sup>st</sup> January 2024. We are in the process of preparing a written response to the consultation.

#### **Healthwatch Westminster's Translation project**

Our <u>Translation report</u> was published in July 2023. Since then, we are in the process of escalating the concerns to the Primary Care Executive Group meetings.



## Healthwatch Westminster's Food aid report

Our <u>Food aid report</u> was published in July 2023. Since then, we have been monitoring progress at the Food and Energy network meetings. The recent food and energy network meeting indicate development have been made with regards to recommendations 1, 2, and 3.

Hafs Academy partners with local food merchants in the community to create food vouchers to meet the essential needs of residents. Their food vouchers scheme are available in Church Street, Edgware Road, and Little Venice Ward,

Westminster Chapel Food Bank have partnered with the Salvation Army to meet the demands of vulnerable population groups. They aim to continue to expand their connections.

St. Andrews youth club have created a school uniform bank to support parents with children facing extreme financial pressures.

The Abbey Centre Food Pantry are still meeting the acute needs of residents and have partnered with unfold to deliver refugee meals in the community, funded by the healthy communities project.

## **Healthwatch Podiatry report**

Our <u>Podiatry report</u> was published in August 2023. Since then, we are in the process of obtaining feedback from the CLCH team to monitor the changes that have been made or are pending, and any new emerging priorities.

#### **Emerging priorities**

There are a number of areas that have been brought to our attention both through community outreach, and strategic stakeholder events:

- Experiences of the refugee and asylum communities access to primary care services
- Level of service offered by local pharmacies, focusing on the extended services proposed by NHSE and the availability of private spaces to speak to a pharmacist

We will continue to monitor these issues during our regular engagement, to build up enough evidence to create a project proposal.
